Abstract of the Rights and Privileges section in Article of Association:

Rights and Privileges

- 18. The right and privileges of membership shall be exclusive to the Members and such right and privileges shall not be transferable by their own act or by operation of law and shall cease upon their dissolution or ceasing to be Members for any cause under the provisions of the Articles.
- 19. Each member shall have the following privileges:
 - (a) To attend all general meetings of the Association.
 - (b) To be recommended for office.
 - (c) To enjoy discount products and services from IT & consumer product vendors.
 - (d) To receive newsletters and magazine from Association and International Linux/IT Association.
 - (e) To enjoy interest group discussion panel of the Association.
 - (f) To enjoy web marketing tools and directory listing service.
 - (g) To attend all function such as seminar, exhibition, training, conference and etc of the Association.
 - (h) To enjoy any function and social gathering conducted by the Association.
 - (i) To enjoy recognition by local, national and international Linux communities.
- 20. Each Corporate Member shall have following privilege in addition to Article 19.
 - (a) To elect the Members of any Committee of the Association.
 - (b) To be elected as a Committee Member (At least 12 months membership is the pre-requisite to be a Committee Member, except for the members of the first Executive Committee).
 - (c) To make proposals and vote for or against the same, and collect to make proposals and vote for or against the same, and collectively to remove member of the Executive Committee.
 - (d) To nominate representative to the Association.
